For a long time, social proximity, neighbourhood, and long-term sharing of local space were considered a central prerequisite for community building and the articulation of collective interests. Throughout history, various social and political initiatives and associations have reflected this in their approaches to social reform, as well as in their specific forms of recruitment, organization and social mobilization. In recent times however, spatial mobilities increasingly govern the everyday lives of large sections of populations around the world. Mobile ways of life arise from demands of globalized job markets, specific arrangements in family and personal relationships, or sophisticated leisure activities. Beyond the effects on individual lifeworlds and lifecourses, the novel trans- and multi-local patterns also have a strong impact on how people build solidarities and engage in the realm of civil society. The workshop will take a closer look at the question of how a sense of community and collectivity is formed under mobile circumstances, how networks of solidarity and modes of participation function beyond locally rooted forms of organizing.
